Following is a summary of the public questions and comments from the Land & Shoreline Management Plan meeting held on January 17, 2000 at the Eagle View Building at Lake Ogallala.

1. How much input was received from the public before determining Day Use Areas (DUA)?
2. Does Central own land North of railroad?
3. Will day use areas in Species Protection Zones (SPZ) become too busy, and have to be changed to No Use?
4. Will SPZ be fenced off from development areas?
5. Will Non Motorized Vehicle Zones (NMVZ) be year round?
6. Will NMVZ be able to have marinas?
7. Are all agencies aware of these plans?
8. Will there be camping along development areas?
9. Restricting use on South side to day use is against public desire!
10. As development is done on South side – public access will be limited.
11. Will there be signs to post restricted areas?
12. If it's not broke don't fix it, leave the lake alone!
13. Do a better job of convincing us that FERC wants this!
14. Central's board must approve this first – (public) talk to them!
15. Tell FERC we will leave it as is – what would they do?
16. Has anybody from FERC been out here?

17. Where do we get a copy of FERC license and recommendations?
18. Are motorized vehicles and over night camping limited in NGPC areas that are SPZ?
19. Is a development proposed for the Kelly Bay area?
20. Do you have concerns about beach erosion?
21. What would be plan to solve erosion at Mako 'ChiMni area?
22. What is % of shore that will be day use only?
23. Is NGPC leaning towards day use areas?
24. Who pushes issues on endangered species?
25. How much of day use area is actually useable?
26. Where is elevation point 3282 marked?
27. What about livestock access on beach in SPZ?
28. What is terminology of public land?
29. Do you have maps back to the 1940's that would show erosion up to now?
30. We want to see plan for erosion control – past and future!
31. Will plan restrict letting water level drop?
32. Does FERC require Central to release water during flooding downstream from South Platte River?

1. Does our contract (Jeffrey) say that we can't have commercial development?
2. Is residential area at Jeffrey zoned R-1?
3. Is there a water set back on South end?
4. Don't like the idea of future development area on Northeast side.
5. Why is residential area on Northwest side not marked on map?
6. Why not pump sediment back to West up canal?
7. Would agree with no additional housing, also would say the delta has doubled in size in 7 years.
8. Does cement bagging help? Have you seen any difference in erosion?
9. Is public input used to develop the plan?
10. Does future development area at Jeffrey reflect full development at Johnson Lake?
11. Is Plum Creek wakeless boating?
12. Can FERC tell you to have more public access?
13. Most people would like to work with Central to remove silt.
14. If we raise enough cane with FERC, will sediment be removed?
15. Feed back on hunting at Jeffrey – Have blinds registered, will know who they are.
 - any place I hunt, I pay.
 - Talk to Bob Raymond, he knows who is hunting.

16. Can we put steel in concrete bags?
17. Corp of Engineers suggested that we use concrete bags.
18. Midway has put up their own signs for wakeless boating.

Following is a summary of the public questions and comments from the Land & Shoreline Management Plan meeting held on January 13, 2000 at Kirk's Nebraskaland Restaurant in Lexington, NE..

1. How does this plan affect the current cabin owners?
2. Do we have to remove existing - non-allowable - seawall materials?
3. Do we have to cut metal out of broken concrete used for seawalls?
4. Will our docks be grandfathered in?
5. Will Central make efforts to preserve the island?
6. What are Central's habitat protection requirements in regard to the island?
7. Can anything be done about the trees falling into the water from the island?
8. Will Central need to buy out some of the current leased areas to allow public access?
9. Who were surveyed for the recreation survey?
10. How much has the lake silted in?
11. Comments on wakeless boating from Plum Creek thru Gallager Canyon -
 - Water skiers turn in area upstream from concrete bridge (59.7)
 - Start wakeless boating at wooden bridge upstream (59.0)
 - Leave Gallager Canyon no wake
12. Will residential shoreline be wakeless boating?
 - Concern with jet skis going thru skiers in shallow areas
 - Is there a 90 ft. restricted zone by NE. Law now?
 - Bouy's placed to mark restricted boating would create racetrack

13. Will Central be required to keep track of silting in the lake?
14. Will anything be done with hike/bike trail?
 - Could use road along E-65 canal
15. If Central were bought out, what would happen to cabin owners?
16. Is boating access unlimited to Johnson Lake, or could some form of permit be used?
17. Will plan be available before next public hearing?
18. Are there any Terns or Plovers on Johnson Lake?
19. Will Phillips Lakes remain the same for boating?
 - Erosion caused by increasing water levels every year
